The course is based on lectures explaining the part of the theory with examples and illustrations, a large part depends on student reading to prepare the analysis. A group project on a European issue solidifies the learning.
Contenu	<p>The first part of the course will be devoted to a description of the resources of the European Community:</p> <ul style="list-style-type: none"> • natural resources (raw materials, agriculture and energy) and associated community policies; - • human resources (demography and the active population, education and training, and work productivity); • capital stock, its productivity and the level of technology; and national and Community policies in this area. <p>The second part will be given over to the structural characteristics of the Community economy, and will compare it with dominant economies (i.e. the USA and Japan):</p> <ul style="list-style-type: none"> • production, consumption, savings and investment; • the distribution of incomes and regional disparities; • the balance between the private sector, the public sector and the unofficial economy; • external trade and investment. <p>The third part will deal with regional integration, and particularly with:</p> <ul style="list-style-type: none"> • the Single Market: freedom of movement (people, goods, services and capital), shared disciplines (competition, and fiscal and social fields) and support policies; • the European Monetary System and its possible evolution into a Monetary Union. <p>The fourth part will examine the Community's capacity for action on the world stage:</p> <ul style="list-style-type: none"> • the issue of international trade; • monetary problems and macroeconomic problems; • the issue of north-south and east-west relations.
