| Thèmes abordés | Migration and mobility, both from outside the EU and in the form of the free movement of citizens within the EU, are high on the EU's political agenda. These are controversial issues that divide Member States as well as national public opinions. The aim of the course is to provide students with an understanding of interconnected and often contentious issues in these rapidly evolving areas. The course explores the dynamics of migration and mobility in the EU, including the different types of migration – regular and irregular migration, free movement of EU citizens, asylum – and the primary developments in contemporary border control and security practices. From an interdisciplinary perspective, drawing on political science, law, economy, and sociology, it examines the rationale of migration policies, politics and law, combining a theoretical and practical account of the field. The course also delves into the challenges of the Schengen area and analyses the so-called "migration crisis". | | |
