An emphasis is given to the study of the socio-economic and environmental implications of the Common Agricultural Policy of the European Union and its evolution towards a better targeted policy.

	Students have acquired the skills to examine the socio-economic effects of the instruments of agricultural, food and rural food policies, in particular the Common Agricultural Policy. They are able to critically reflect on the CAP and provide evidence-based argumentation on how to improve it. They are encouraged to take up their role as engaged citizen in policy making, by improving their communication skills with their peers and contacting professionals in the field.

	Policy (CAP) and how it deals with the economic, social and environmental challenges associated with EU food systems. Next, students become aware how these policies are embedded in and shape our daily lives through the discussion of recent news articles. Students learn to assess how effective and efficient the CAP is in realizing these objectives through theory lectures and group discussions of scientific papers.
