Research, analyze and understand references to architectural integration in a built environment and defend a specific position on the basis of a critical analysis. • Analyze, evaluate and identify the appropriate options for a restoration project, connecting this analysis to the underlying intervention philosophy in order to make a case for it. <p>Contribution to the referential learning outcomes of competences:</p> <p>Designing an architectural project: faced with an architectural issue, students will know how to discern, analyze and integrate certain elements of a reality in the making. They will then produce hypotheses on the basis of which the choice of a coherent format will redefine the place."</p>
Evaluation methods	<p>A written exam including:</p> <ol style="list-style-type: none"> 1. multiple-choice questions: general assessment of passive knowledge acquisition 2. matching questions: assessing the ability to link building plans, references, periods and sites 3. an open-ended question: assessment of active understanding of knowledge
Teaching methods	<p>Lectures of 2 hours, each week.</p> <p>If circumstances permit, projections of documentary sequences related to heritage, outdoor visits of examples of remarkable heritage.</p>
