Evaluation methods	Continuous formative assessment (not graded) and certificative assessment (examination) at the end of the term. Examination : <ul style="list-style-type: none"> • 1st session : June; • 2nd session : August/September.
Teaching methods	Face-to-face course with the possibility of distance learning. Students' performances are commented on and analyzed by both peers and the teacher. Suggestions for improvement are made.
Content	The course "Consecutive Interpreting Practice Dutch > French" is a continuation of "Consecutive Interpreting Techniques" (LINTP2330) from the first semester. Basically, it pursues the same objectives: understanding and analyzing Dutch speech in depth, improving note-taking skills, rendering the speaker's train of thought, knowledge of the situation in Flanders and the Netherlands and their cultural particularities, precision and fluency in the language of expression, quality of communication. Presentations in Dutch focus on current affairs and social issues. They are now longer and slightly denser in content than in the first term.
