	January and August/September sessions: written examination.				
	Students are required to take <b>one written examination per translation workshop</b> (i.e. economic, legal, ar scientific/technical translation) in the working conditions of a professional translator's workstation. Each exam w consist in the translation of one or several texts on matters in connection with the topics dealt with over the cours of the termThe use of machine translation is strictly forbidden.				
	The use of MT (machine translation) software or software based on AI (artificial intelligence) is strictly forbidden in any translation exercise or examination work, except - where appropriate - in the specific context of a post- editing exercise proposed by the teacher for teaching purposes. Similarly, the use of software based on AI (artificial intelligence), such as ChatGPT, is strictly forbidden in writing and editing exercises.				
	Unless explicitly specified otherwise, the use of machine translation software or generative artificial intelligence (AI) is STRICTLY prohibited, whether in the context of practical exercises or examinations. 	The <b>final grade</b> will consist of three integrated parts of equal importance. Each specialized translation worksho being worth one third of the final evaluation of the training unit, the overall mark will be calculated by averagin the three marks.				
	A pass (i.e. 10/20 or more) in at least two of the three parts is required to demonstrate the skills and knowledg laid out in the learning outcomes of the course.				
	A failing grade (i.e. less than 10/20) in two parts of the course will result in a failing grade for the whole course. the final mark is less than 10/20, the failed parts will have to be taken again during the August/September exa session.				
	Students who have failed the course when the academic year ends will have to take all three translation workshop (economic, legal, scientific/technical) the following year.				
Teaching methods	Lectures and training sessions. Lectures on translation of specialised discourse. Practical exercises of translation that must be done according to instructions given by the teacher.				
	In-situ training in specialized translation in the working conditions of a professional translator's workstation preliminary work via the e-learning platform (if need be).
