Learning outcomes	<p><b>At the end of this learning unit, the student is able to :</b></p> <ul style="list-style-type: none"> <li>• obtain <b>knowledge</b> about the financial markets: learn how to <b>define</b> and <b>identify</b> fundamental financial concepts, among which e.g. financial products.</li> <li>• <b>understand</b> financial economic newspaper articles (and reports) and <b>explain</b> them in their own words.</li> <li>• <b>apply</b> the theoretical concepts during exercise sessions during which financial problems will be solved (e.g. with respect to time value of money, the term structure of interest rates, pricing of financial instruments and the risk-return trade off) and graphical representations will have to be made.</li> </ul>
Evaluation methods	<p>1. Written exam (90% of the final grade) During an on-campus closed-book exam, students will need to identify, define and explain theoretical concepts as well as solve numerical problems.</p> <p>2. Group assignment (10% of the final grade) Students will be asked to participate in a (virtual) trading game (using a trading platform), define their trading strategy and explain their trades. The use of artificial intelligence to search for information, write or improve the assignment must be specified. Sources of information must be systematically cited. Students remain responsible for the content of their work, regardless of the sources used.</p>
Teaching methods	<p>The lectures During the lectures the theoretical concepts will be explained. Students will be encouraged to participate to class, answering to questions that will be raised (e.g. using Wooclap). Financial examples applying theoretical concepts will be demonstrated, together with a (virtual) trading example and financial applications in MS Excel.</p> <p>TA sessions Students will have the opportunity to solve problems under the guidance of an assistant, who will demonstrate the exercises. Students are encouraged to review the lecture before attending exercise classes.</p>
Content	<p>Money and the financial system will be introduced. In order to enable the pricing of financial instruments, the time value of money will be addressed. Present and future value calculations of a single cash flow, of cash flow streams, annuities and perpetuities will be taught.</p> <p>Both money market (treasury bills, commercial paper, repo) and capital market products (bonds, stocks) will be discussed. We will go into the pricing and the risk of bonds and stocks. Financial derivatives will also be introduced. The importance of financial intermediaries is also addressed, focusing on the structure of the financial industry, financial institutions and the regulator.</p>
Inline resources	<p>On the university's electronic platform the following additional information will be offered:</p> <ul style="list-style-type: none"> <li>- a copy of the slides used in class</li> <li>- the exercises that will be solved during the exercise classes. Additional exercises will be added (partially with solutions)</li> <li>- (simple) MCQ tests that will enable students to verify whether they can identify key concepts in financial markets.</li> </ul>
