Evaluation methods	<p>Student assessment is based on two elements: firstly, individual and group exercises carried out on a continuous basis throughout the course, and secondly, a final written assignment carried out individually.</p> <p>In addition, participation in optional exercises and contributions to the forum devoted to course questions will earn up to two bonus points.</p> <p>All written work must be submitted directly via the course Moodle page.</p>
Teaching methods	<p>The course comprises two main phases.</p> <p>The first phase takes place face-to-face during the first seminar of the year. It consists of two lecture sessions.</p> <p>The second phase takes place remotely over a period of four weeks. It combines synchronous and asynchronous activities, as well as individual and collaborative activities.</p> <p>All the necessary resources (commented powerpoint presentations, descriptions of exercises and methodological advice, portfolio of readings, links to multimedia resources, etc.) are available on the course Moodle page.</p>
Content	<p>The aim of this course is to introduce students to the political system of the European Union and how it functions through an analysis of its institutions, actors, modes of government and public policies. The political effects of European integration on national policies and on the citizens of the Member States are also examined.</p>
