Place of the course	Louvain-la-Neuve
Main themes	In order to achieve its set objectives, the course will tackle the issues facing sacramental practice and reflection today in the wake of the liturgical reform initiated by the Second Vatican Council and the challenges of secularization and unity of Christians.
Learning outcomes	<p>At the end of this learning unit, the student is able to :</p> <ul style="list-style-type: none"> - to use the instruments of work, especially the rituals resulting from the liturgical reform, concerning the sacraments; - to situate the liturgical and pastoral issues of current sacramental practices. <p>According to the Bachelor's Degree in Religious Sciences:</p> <p>1</p> <ul style="list-style-type: none"> A. to master the knowledge to explain Christianity in its cultural environment according to theological disciplines; A.3. to understand and explain the liturgical and pastoral situation of a Christian community; A. 5. to understand and interpret historical and juridical sources relating to the Christian Faith; <p>B. Evaluation methods	<p>Students following the course in class will be assessed on the basis of the following exercises:</p> <ul style="list-style-type: none"> • Eight short reading and analysis assignments on ancient and/or contemporary conciliar or liturgical texts (called 'homework'), to be completed before the course concerned by each assignment (20%). • An exercise in observing a Eucharistic liturgy (20%); • An oral examination in which the student tackles a liturgical or sacramental pastoral issue, based on a personalised re-reading of the course (60%). <p>Except in the case of students taking the course solely by distance learning, attendance is compulsory. In the event of absence, students will be asked to complete a short quiz on the content of the session, based on the course notes available on Moodle.</p> <p>Students following the distance learning course will be assessed on the basis of the following exercises:</p> <ul style="list-style-type: none"> • Eight short reading and analysis assignments on ancient and/or contemporary conciliar or liturgical texts (called 'homework') and eight short formative quizzes on the first part of the course and on each of the sacraments (4/20). The short quizzes allow you to check whether students have acquired the essential elements of the course. They are not assessed, but you must complete them to pass the course. • An exercise in observing a Eucharistic liturgy (20%); • An oral examination in which the student tackles a liturgical or sacramental pastoral issue, based on a personalised re-reading of the course (60%). <p>The same assessment method will be used in September.</p>
Teaching methods	The course will consist in lectures, personal work on biblical and historical texts as well as on contemporary liturgical documents to develop students' analytical skills and their liturgical and theological sensitivity. Students will also have to observe a celebration of the Eucharist which will be discussed in a class session.
Content	After a thematic and historical introduction that will focus in particular on the implementation of the liturgical reform initiated by the Council, the course will work by dossier; for each dossier, a biblical and historical approach will

	<p>prepare the theological and liturgical reflection, for which reference will be made to the corresponding liturgical rituals. The 'Baptism' and 'Confirmation' files will address the issue of initiation from the point of view of the renewal brought about by the liturgical approach to the catechumenate of adults. The 'Eucharist' dossier will look at the practice of the Eucharist from the perspective of the major options of liturgical renewal. The 'Sacrament of Reconciliation' dossier will look at the challenges of the new ritual and the difficulties encountered in implementing it. The 'anointing of the sick' section will look at the transition from 'extreme unction' to 'anointing of the sick'. With regard to ordinations, the course will look at the ecclesiological implications of the choices made in the new ritual. Finally, for the 'sacrament of marriage', we will study the new ritual and the reflection on the preparation of this sacrament.</p>
