#### Introduction

The School of Criminology provides specialized multidisciplinary training which allows to understand crime in all its complexity. The training focuses on several disciplinary areas: criminal law and criminal practices; psychological processes involved in the transition to the crime; social factors acting out and social mechanisms of creation of criminal law and the conditions of its application; study of human behavior in its interaction with biological, social and psychological dimensions.

#### Your profil

- Are you interested in issues of deviance;
- you plan to perform duties in the field of prevention and repression of crime;
- you place the individual at the center of your concerns and you want to be socially useful;
- you are looking for a training that prepares you for the response on the ground.

#### Your futur job

Fields of action of the criminologist are:

- the Courts (federal and local) and prisons;
- the youth welfare: social service courts, facilities for children in care teams in the community, etc.;
- the prevention services created under security contracts and society;
- the Mental Health and Addiction;
- the social assistance to individuals (remand prisoners, detainees, victims, etc..) in the homes of justice in victim services, etc.;
- the research.

#### Your programme

The master offers:

- an interdisciplinary approach to deviance from the norm (sociology, law, psychology and biology);
- a specialized training in legal matters in connection with the crime and the penalty;
- an applied learning intervention: Maintenance behaviors, conflict management and crisis situations, etc.;

The Master in Criminology offers a Professional focus "criminology of the intervention" and a Research focus.

## CRIM2M - Teaching profile

### Learning outcomes

The goal of the master is to offer the students the theoretical and methodological resources to understand criminality and penalty and, more generally, deviance and social control.

The professional focus master aims to help students specialise in intervention in order to be able to teach in sectors aiding and protecting young people, the police, executing penalties and criminal measures, legal aid and dealing with delinquency.

The research focus master aims to train students in careers in research and analysis in the fields of psychological or sociological criminology and criminal policy.

Skills developed :

- Deeper understanding and critical analysis of criminality and penalty, deviance and social control, and the scientific work devoted to these phenomena;
- Conducting interviews ; intervening in situations of conflict and crisis, reflecting on intervention practices
- Wording of research questions; building up research tools; carrying out empirical research; thinking about research practices.

Knowledge to acquire :

- Major theories in psychological and sociological criminology from the crime to the administration of criminal justice;
- Intervention and research methodology ;
- Legal matters in relation to criminality and penalty.

On successful completion of this programme, each student is able to :

- **Maîtriser** de manière intégrée **un corpus de connaissances relatives aux disciplines principales** (droit, psychologie, psychiatrie, sociologie, sciences médico-légales) autour desquelles s'articule la criminologie, corpus sur lequel le diplômé s'appuie pour comprendre et réfléchir une « situation-problème » intéressant la criminologie.
- Maîtriser le corpus de lois et de règles qui d'une part érigent certaines situations en infractions et d'autre part définissent et organisent les façons dont les autorités publiques les appréhendent et les résolvent.
- Maîtriser les théories psychologiques, psychiatriques, sociologiques et médico-légales mobilisées par la criminologie pour expliquer ou problématiser ces situations, phénomènes définis comme criminels ou perçus comme déviants.
- Étudier les processus de création des lois et des règles, leur application, ainsi que les usages et effets de la pénalisation des situations.
- Analyser de manière approfondie les éléments politiques, économiques, sociaux et psychiques en jeu dans la réaction sociale formelle et informelle.
- Analyser de manière approfondie les processus psychiques et sociaux en jeu dans les passages à l'acte et dans les carrières déviantes.
- Analyser de manière critique ce que la problématisation criminologique des situations pénalisées ajoute ou enlève à leur intelligibilité.
- **Maîtriser et mobiliser la rigueur de la méthodologie** indispensable à toute intervention et à toute réflexion sur des questions intéressant la criminologie.
- Faire preuve de la rigueur, de la précision et de l'esprit critiques indispensables à toute démarche scientifique.
- Réfléchir de manière scientifique les phénomènes qui intéressent la criminologie en fonction des facteurs psychologiques, psychiatriques, médico-légaux, sociologiques, économiques, politiques, historiques et culturels.
- Maîtriser et mobiliser les outils d'analyse tant statistiques que qualitatifs pertinents pour l'étude de problématiques données.
- **Analyser de manière critique, selon une approche transdisciplinaire et réflexive, des « situations-problèmes » intéressant la criminologie** et contribuer à l'élaboration de réponses et d'actions concrètes et contextualisées.
- Approcher les réactions sociales formelles et informelles et les « situations-problèmes » auxquelles elles s'appliquent en articulant les différents angles d'analyse disciplinaires et en tenant compte des limites de chaque discipline et de leurs interrelations.
- Appliquer une méthodologie rigoureuse qui, tout en composant avec les incomplétudes, permette tout à la fois de problématiser la « solution » pénale et de résoudre les « situations-problèmes », au moyen de débats constructifs entre les diverses disciplines mobilisées par les criminologues.
- Dans ce dialogue transdisciplinaire, faire preuve de réflexivité et de recul critique, vis-à-vis d'autrui et de soi-même.
- Analyser, évaluer, restituer clairement et établir des liens entre des informations et des points de vue différents, en interaction avec les acteurs et institutions impliqués dans les « situations-problèmes ».
- Élaborer des stratégies et des actions concrètes en faisant preuve d'ouverture et de créativité
- Confronter théorie et pratique, notamment à travers une expérience de stage, afin d'apprendre à porter un regard critique sur le fonctionnement d'une institution et sur un ou plusieurs type(s) de situations problématiques.
- **Analyser les pratiques d'intervention et leurs logiques** pour apprendre à se positionner dans divers champs d'intervention avec pertinence et réflexivité.
- Connaître, comprendre, analyser et porter un regard critique sur différentes institutions (par exemple : les organisations policières, les tribunaux, les prisons, l'aide à la jeunesse, l'aide aux justiciables, la santé mentale ...) qui font l'objet des études de criminologie.
- Comprendre, analyser et critiquer de manière argumentée et selon une approche transdisciplinaire les fondements théoriques, la pertinence et les limites des principaux modes, techniques et pratiques d'intervention des criminologues.
- Différencier la pluralité d'intervention et leurs types de finalités et penser l'articulation entre, d'une part, la prévention/protection et le traitement et, d'autre part, la répression, la sanction, la probation, la guidance, la médiation, la réparation...
- Maîtriser et appliquer les outils méthodologiques liés à l'élaboration, la mise en œuvre et l'évaluation des pratiques d'intervention dans les divers champs qui intéressent le criminologue.

- **Concevoir et réaliser un travail de recherche de nature transdisciplinaire** (mémoire), mettant en œuvre une démarche scientifique et méthodologique rigoureuse, pour approfondir une question de recherche inédite relative aux usages du pénal et aux situations-problèmes qui intéressent la criminologie.
  - Formuler une question de recherche complexe.
  - Rendre compte de l'état des connaissances sur cette question.
  - Construire et mettre en œuvre un dispositif méthodologique rigoureux et pertinent en vue d'y répondre.
  - Concevoir et réaliser, le cas échéant, une recherche empirique quantitative et/ou qualitative, en mobilisant les outils d'analyse adéquats.
  - Analyser et interpréter les résultats.
  - Développer un esprit de synthèse et formuler des conclusions.
  - Faire preuve, de manière générale, d'un recul critique tant sur son propre travail que sur les connaissances qui y sont mobilisées.
  - **Communiquer, dialoguer, collaborer et tenir la fonction d'interface** avec les différents acteurs impliqués dans une situation donnée.
  - Communiquer, à l'oral et à l'écrit sur des sujets complexes (des informations, des idées, des conclusions, des pistes d'actions concrètes, ainsi que les connaissances et principes sous-jacents) de façon claire, structurée, argumentée selon les standards de communication spécifiques au contexte et en adaptant sa présentation au public visé et aux intentions poursuivies.
  - Dialoguer de manière respectueuse et constructive avec des interlocuteurs variés (tant d'un point de vue socio-culturel, qu'au départ de leur fonction, de leurs champs d'action et de leur domaine disciplinaire d'expertise) en faisant preuve de capacité d'écoute, d'ouverture d'esprit, d'empathie, de distanciation et d'assertivité.

## Programme structure

The programme of the Master in Criminology is built around core courses mainly taught in the first year, on the basis of which students are invited to take the research or professional focus in the second year, as described above, for a total of 120 credits.

The **program of the first year** of the master consists of:

- courses and practical exercises of core (compulsory) (distributed throughout the year);
- a course in English or Dutch;
- the accompanying seminar (2nd semester).

The **program of the second year** of the master consists of:

- a course in English or Dutch;
- a **choice of focus**, accounting for 30 credits (5 courses of 6 credits, spread over 2 semesters):
  - specialized in criminology purpose of the intervention,
  - the research focus,
- **professional internship** of 300 h and its accompanying seminar (1st semester);
- the **dissertation** (spread over the whole year).

*For a programme-type, and regardless of the focus, options/or elective courses selected, this master will carry a minimum of 120 credits divided over two annual units, corresponding to 60 credits each.*

## Course prerequisites

---

A document entitled #nom\_fichier\_pdf# specifies the activities (course units - CU) with one or more pre-requisite(s) within the study programme, that is the CU whose learning outcomes must have been certified and for which the credits must have been granted by the jury before the student is authorised to sign up for that activity.

These activities are identified in the study programme: their title is followed by a yellow square.

As the prerequisites are a requirement of enrolment, there are none within a year of a course.

The prerequisites are defined for the CUs for different years and therefore influence the order in which the student can enrol in the programme's CUs.

In addition, when the panel validates a student's individual programme at the beginning of the year, it ensures the consistency of the individual programme:

- It can change a prerequisite into a corequisite within a single year (to allow studies to be continued with an adequate annual load);
- It can require the student to combine enrolment in two separate CUs it considers necessary for educational purposes.

## Teaching method

---

### First year of the master

Cross-disciplinary training in sociology, psychology and law

### Second year of the master

Professional focus: the professional focus prolongs the core courses through cross-disciplinary training made up of criminological integration courses.

The student's understanding of criminality, penalty will be put to the test through a 300h internship, which will also help him develop analytical and intervention skills.

**Research focus:** the research focus prolongs the core courses by going into more depth on major theoretical views, not by giving the student encyclopaedic knowledge but rather with a view to highlighting the link between epistemological, theoretical and methodological options.

## Evaluation

---

**The evaluation methods comply with the [regulations concerning studies and exams](#). More detailed explanation of the modalities specific to each learning unit are available on their description sheets under the heading "Learning outcomes evaluation method".**

Each course on the programme includes an oral or written exam, possibly completed by a project leading to a report which forms part of the evaluation.

The internship involve the preparation of a report being evaluated.

The work on the dissertation involve the drafting of a document which will be presented orally to a jury.
