Introduction

Your programme

The master offers:

- a common base of fundamental legal subjects;
- a choice of options during the two years;
- the choice of a professional focus in the second year;
- writing a thesis;
- an internship or an exchange program (in Belgium or abroad).

DROI2M - Teaching profile

Learning outcomes

After a three-year bachelor, the programme in Master en droit has the dual objective of adding to the student's general training by teaching fundamental subjects (core courses) and providing him with specialist training in subjects more closely linked to his future professional career (focuses and optional courses). The student chooses his specialisation from the coherent set of subjects.

The balance between general training and specialised training should provide the student with the opportunity to acquire legal skills of a highly technical level, aided by skills in critical reflection.

The Master's programme is also intended to help students familiarise themselves with the world of work (internship and dissertation), broaden their linguistic skills (English courses and exchanges with KULeuven) and perfect their training abroad (Erasmus exchanges).

On successful completion of this programme, each student is able to :

1. APPROFONDIR

Maîtriser le contenu des principales règles du droit positif belge dans toutes ses branches, ainsi que celles du droit européen et du droit international, pouvoir en comparer les traits essentiels à quelques systèmes étrangers et être capable de passer de l'abstraction de la règle de droit aux faits, fussent-ils présentés de façon complexe, et inversement.

2.1. Avoir une connaissance actuelle et une maîtrise générale des principes, règles, théories, doctrines et jurisprudences donnant corps aux différentes branches du droit, en particulier le droit fiscal et le droit comptable, le droit international privé, le droit international public, le droit des sociétés, le droit patrimonial de la famille, le droit de la sécurité sociale et le droit des sûretés.

2.2. Connaître et comprendre l'influence qu'ont certaines normes et institutions européennes et internationales sur ces différentes branches du droit.

2.3. Connaître quelques traits essentiels de ces mêmes branches du droit à l'aune de quelques systèmes étrangers et maîtriser les techniques et les réflexes de recherche en droit comparé aux fins d'approfondir ces connaissances.

2.4. Rechercher, lire et comprendre des documents juridiques écrits en néerlandais et en anglais ou en allemand.

Être capable de suivre un cours universitaire dans une de ces langues.

2.5. Dans l'une ou l'autre branche du droit, pouvoir, de manière autonome et créative, diagnostiquer un problème juridique complexe, en discerner, dans les moindres détails, les difficultés, en élaguer les éléments périphériques, y apporter des solutions argumentées, fondées sur des recherches approfondies, livrées dans une synthèse claire sous-tendue par un raisonnement juridique poussé, cohérent et crédible.

2.6. Être capable de passer de l'abstraction de la règle de droit aux faits concrets, et inversement.

3. EXPLIQUER ET CONVAINCRE

Passer aisément de la règle aux faits et inversement lors d'une discussion, communiquer de manière claire, précise, structurée et argumentée le fruit d'une recherche et le résultat d'une analyse juridiques et produire une étude juridique, dans le respect le plus absolu des règles gouvernant la production scientifique.

3.1. Lors d'une discussion (colloque singulier, conversation collective, discours argumentatif, consultation écrite ou orale, etc.), être capable de passer de l'abstraction de la règle de droit aux faits concrets, et inversement.

3.2. 3.4. Participer à une conversation courante sur une question juridique de difficulté moyenne dans une autre langue que le français (en particulier en néerlandais ou en anglais).

3.5. Subordonner toute forme de communication personnelle au respect le plus absolu des règles gouvernant la production scientifique (citations littérales, références, bibliographie, etc.).

4. RÉFLÉCHIR ET PARTICIPER

Actualiser ses connaissances, percevoir les passerelles entre les différentes branches du droit, se forger des opinions personnelles et, le cas échéant, faire fructifier l'ouverture résultant d'un stage ou d'un séjour d'échange.

4.1. Être capable d'actualiser et de parfaire ses connaissances dans les différentes branches du droit de manière autonome, et d'ainsi se forger une solide culture juridique générale.

- soit de cours dispensés en faculté par des professeurs étrangers.

Programme structure

The student constructs his programme to include four main coherent sections: core courses, a dissertation (and supporting seminars), a focus (30 credits) and 25 ects of optional courses.

The programme of the first year of the Master is made up of:

- courses and a tutorial from the core courses ;
- the supporting seminars for the thesis ;
- optional courses for 15 credits (2nd semester).

The programme of the 2nd year of the Master is made up of:

- a lesson of Law, change and society.
- a tutorial in the selected focus.
- a selected focus, from the eight focuses available (on selection) either at UCLouvain, at KUL or abroad (1st semester) ;
- the thesis (spread out across the year) ;
- 10 ects of optional course, from the optional courses available or optional courses taken abroad at a partner university (Erasmus) (2nd semester).
