Prerequisites and student's annual programme

In addition, when the jury validates a student's individual programme at the beginning of the year, it ensures its coherence, meaning that it may:

- require the student to combine registration in two separate CUs which it considers necessary from a pedagogical point of view.
- transform a prerequisite into a corequisite if the student is in the final year of a degree course.

Teaching method

Ce programme spécifiquement conçu pour des personnes qui travaillent, alterne exposés théoriques et études de cas afin de permettre la compréhension concrète des problématiques de gestion.

Le programme attire un public de formation et d'horizons professionnels très variés.
