Introduction

The Saint-Louis Bruxelles campus offers a bachelor's degree programme in political science during the day, as well as in the evening, which is unique among French-speaking universities in Belgium. For over thirty years, Saint-Louis has offered an evening programme for those who wish to further their education or redirect it, while working or looking for a job during the day.

Classes are held Monday to Friday, from 5.15pm to 8.15pm (or 9.15pm). They take place in the centre of Brussels, at the Saint-Louis Bruxelles campus (between the Rogier and Botanique metro stations, near the Gare du Nord). This programme entitles private-sector employees to paid [educational leave](#).

The bachelor's degree in political science mainly involves learning how to understand the mechanisms of power which govern today's world:

- How are decisions made, and at which levels of power?
- Who actually influences decisions and in whose interest?
- What are the main systems of political power both historically and throughout the world?
- How can we explain their emergence, evolution, successes and difficulties?
- What are the main contemporary issues at national, European and global level? Who do they oppose? What are the power relationships involved? What are the possible outcomes?

These are just some of the questions which political science provides answers to through various specialised areas: political parties and interest groups, electoral studies, international relations, political regimes, etc. A bachelor's degree in political science addresses these different issues.

The programme also includes course units in the humanities – sociology, philosophy, law, economics, etc. – which shed light on human relations, how they function and how they evolve. Students will also acquire in-depth knowledge of data collection and statistics, in order to gain an academic understanding of human phenomena.

Your profile

You would like to combine your professional life with university studies, you enjoy topical debates, you want to know more about world developments, you would like to become capable of interacting in English on political subjects, and you have a strong interest in rigorous analysis based on cross-checked data.

Your future job

The political science programme is divided into two cycles: the three-year bachelor's degree and the one- or two-year master's degree. After completing a master's degree in political science (general or international relations), there are many and varied career opportunities:

- Administrative agent for the state, an international organisation, the European Commission or a public body
- Elected official, ministerial advisor, parliamentary attaché, partner in a consulting firm
- Lobbyist in a pressure group, campaign manager in an NGO, attaché for a party, a trade union, an industry association, etc.
- Journalist, consultant, pollster, researcher, analyst in a research department
- Educator in a continuing education organisation
- Teacher (secondary, higher education, social advancement)

Your programme

The programme begins with a range of general courses in the humanities, mainly in year 1. The number of courses in political science, social science methods and English increases each year. It also includes several law courses.

Programme structure

The bachelor's degree in political science (evening programme) is a first-cycle programme (a 'transition' bachelor's degree), consisting of 180 credits spread over three years (60 credits per year).

The programme is divided into two parts: one general, the other of a political science nature.

- The general part of the programme aims to provide a background in the humanities and social sciences. This knowledge is acquired through introductory courses in the main disciplines of the humanities and social sciences (philosophy, history, economics, law, sociology and psychology), and through course units and seminars designed to teach different analytical methods in the humanities and social sciences.

- The political science part of the programme is structured around introductory courses in the main disciplines which make up political science (economics, public law, political sociology, political history) as well as general political science courses (political science, political science: founding texts) and specialised courses (comparative politics, political parties and interest groups, EU politics, analysis of public action, analysis of international relations, etc.).

- require the student to combine registration in two separate CUs which it considers necessary from a pedagogical point of view.
- transform a prerequisite into a corequisite if the student is in the final year of a degree course.

Access Requirements

Decree of 7 November 2013 defining the landscape of higher education and the academic organization of studies.

The admission requirements must be met prior to enrolment in the University.

In the event of the divergence between the different linguistic versions of the present conditions, the French version shall prevail.

General access requirements

Except as otherwise provided by other specific legal provisions, admission to undergraduate courses leading to the award of a Bachelor's degree will be granted to students with one of the following qualifications :

1. A Certificate of Upper Secondary Education issued during or after the 1993-1994 academic year by an establishment offering full-time secondary education or an adult education centre in the French Community of Belgium and, as the case may be, approved if it was issued by an educational institution before 1 January 2008 or affixed with the seal of the French Community if it was issued after this date, or an equivalent certificate awarded by the Examination Board of the French Community during or after 1994;
2. A Certificate of Upper Secondary Education issued no later than the end of the 1992-1993 academic year, along with official documentation attesting to the student's ability to pursue higher education for students applying for a full-length undergraduate degree programme;
3. A diploma awarded by a higher education institution within the French Community that confers an academic degree issued under the above-mentioned Decree, or a diploma awarded by a university or institution dispensing full-time higher education in accordance with earlier legislation;
4. A higher education certificate or diploma awarded by an adult education centre;
5. A pass certificate for one of the [entrance examinations](#) organized by higher education institutions or by an examination board of the French Community; this document gives admission to studies in the sectors, fields or programmes indicated therein;
6. A diploma, certificate of studies or other qualification similar to those mentioned above, issued by the Flemish Community of Belgium, the German Community of Belgium or the Royal Military Academy;
7. A diploma, certificate of studies or other qualification obtained abroad and deemed equivalent to the first four mentioned above by virtue of a law, decree, European directive or international convention;

Note:

Requests for equivalence must be submitted to the Equivalence department ([Service des équivalences](#)) of the Ministry of Higher Education and Scientific Research of the French Community of Belgium in compliance with the official deadline.

The following two qualifications are automatically deemed equivalent to the Certificate of Upper Secondary Education (Certificat d'enseignement secondaire supérieur – CESS):

- European Baccalaureate issued by the Board of Governors of a European School,
- International Baccalaureate issued by the International Baccalaureate Office in Geneva.

8. Official documentation attesting to a student's ability to pursue higher education (diplôme d'aptitude à accéder à l'enseignement supérieur - DAES), issued by the Examination Board of the French Community.

Specific access requirements

- Access to bachelor programmes for candidates of nationality outside the European Union who are not assimilated to Belgian nationals is subject to the following criteria:
 - not have obtained a secondary education diploma for more than 3 years maximum. Example: for an admission application for the academic year 2026-2027, you must have obtained your diploma during the academic years 2023-2024, 2024-2025 ou 2025-2026. In the French Community of Belgium, the academic year runs from September 14 to September 13
 - not already hold an undergraduate degree
- Candidates, whatever their nationality, with a secondary school diploma **from a country outside the European Union**, must have obtained an average of 13/20 minimum or, failing that, have obtained this average, have passed one year of study in Belgium (for example special Maths / sciences). A non-successful year will not be taken into consideration.

- For any secondary school diploma **from a European Union country**, the admission request must contain the equivalence of your diploma or, at the very least, proof of the filing of the equivalence request with the Wallonia-Brussels Federation (French Community of Belgium). For any information relating to obtaining an equivalence, please refer to [the following site](#).
- For any secondary school diploma **from a country outside the European Union**, the admission application must contain the [equivalence of your diploma](#) issued by the Wallonia-Brussels Federation (French Community of Belgium). If you have a restrictive equivalence for the programme of your choice, in addition of it, you **must** have either the [DAES](#) or a certificate of successful completion of the [examination giving access to 1st cycle studies](#) when you submit your application

Access based on validation of professional experience

Admission to undergraduate studies on the basis of accreditation of knowledge and skills obtained through professional or personal experience (Accreditation of Prior Experience)

Subject to the general requirements laid down by the authorities of the higher education institution, with the aim of admission to the undergraduate programme, the examination boards accredit the knowledge and skills that students have obtained through their professional or personal experience.

This experience must correspond to at least five years of documented activity, with years spent in higher education being partially taken into account: 60 credits are deemed equivalent to one year of experience, with a maximum of two years being counted. At the end of an assessment procedure organized by the authorities of the higher education institution, the Examination Board will decide whether a student has sufficient skills and knowledge to successfully pursue undergraduate studies.

After this assessment, the Examination Board will determine the additional courses and possible exemptions constituting the supplementary requirements for the student's admission.

Special requirements to access some programmes

Teaching method

The effectiveness of the programme is ensured by the complementary nature of several teaching methods: lectures as well as exchanges of views which value professional experience and previous career paths, group work, individual work and mentoring.

The teaching methods are designed to make the most of the limited time available to adult students with professional and/or family lives.

Beginning in the first term of year 1, students will have the opportunity to familiarise themselves with university work: specific foundation courses for students in the evening programme, revision period support, etc.

The Academic Guidance Service (AGS) is available to meet students who wish to do so.

Evaluation

The evaluation methods comply with the [Academic regulations and procedures](#). More detailed explanation of the modalities specific to each learning unit are available on their description sheets under the heading "Learning outcomes evaluation method".

Assessments are generally carried out by means of an examination. Examinations are either written or oral. They focus not only on knowledge of the subject matter, but also on a student's ability to apply it to topics not discussed during the course.

Three examination sessions are organised during the academic year, in January, June and August/September. First-year students who do not achieve passing grades in the January session have up to two opportunities to retake specific examinations, in June and/or September.

Mobility and/or Internationalisation outlook

The bachelor's degree in political science (evening programme) does not allow students the possibility to study abroad for one or more terms.
